- Data processed by Dashscored is protected using industry leading standards at all times and at every stage of the data lifecycle.
- Authorization, ingestion, encryption, storage, and access steps all exceed standards set forth by leading state and current federal laws.
- Dashscored clearly outlines customer Terms of Service, Privacy Policies, Data FAQs and makes it easy to elect data preferences.
- Customers can control Dashscored's access to their server data using Discord Role & Permissions as they would with server members.
- The purpose of Dashscored is to help communities, creators and their partners better meet the needs of the people they engage with online. Data captured/ingested/shared/protected via Dashscored is used to understand activity within Discord servers, opportunities for improved engagement and to build more meaningful partnerships.
- Dashscored does not share member's identifiable information for any purpose.
- Data shared with Dashscored is never available for others to access unless you specifically grant access via a Dashscored Partnership account.
- Customers of Dashscored agree to operate in accordance with Discord's Terms of Service, as does Dashscored, and must share in our commitment to protect personally identifiable information and to keep people, communities and shared experiences online safe.

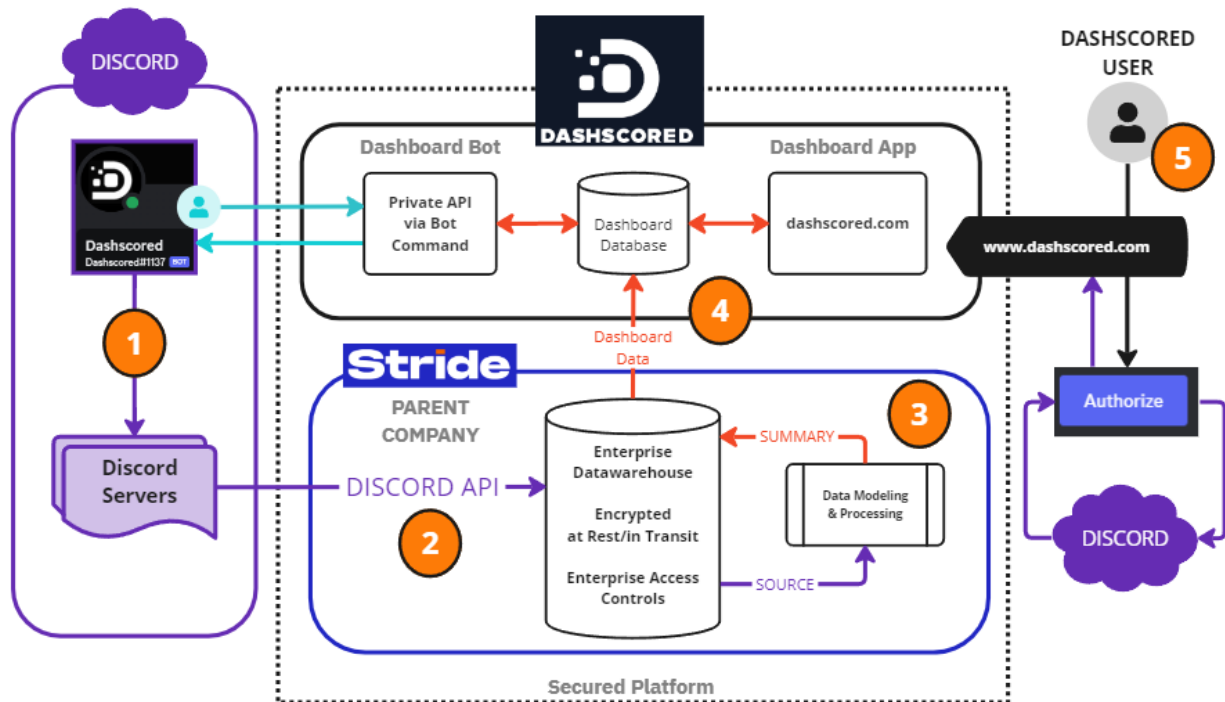

Dashscored Architecture & Data Flow Diagram



1. Bot is installed and permissions to data are authorized by Server Admin or Server Member with installation permission.
2. Data authorized by the Server Admin is collected via Discord API and stored in our enterprise data_warehouse.
 - a. Data_warehouse is operated by Dashscored's parent company Stride Learning: <https://www.stridelearning.com/>
 - b. Data is encrypted in transit on our networks and at rest in the data_warehouse.
 - c. Enterprise access controls are maintained using industry-standard protocols.
3. Source Discord data is converted into Summarized Dashscored data using proprietary data modeling and processing.
4. Dashboard data is loaded into the Dashscored platform and made available to authorized users at www.dashscored.com
 - a. Access to key dashboard reports by Dashscored users via in-platform slash command will be released in Spring 2024.
5. Dashscored is integrated with Discord OAuth2 Authorization Service. Users access Dashscored via authorized Discord log in.
